A. Date, time and venue of the Annual General Meeting (Meeting):

The 18th Annual General Meeting of the Company was held on Wednesday, 24th September, 2025 through two-way Video Conferencing (VC) / Other Audio-Visual Means (OAVM) in accordance with the applicable provisions of Companies Act, 2013 read with the Rules issued thereunder and the Securities and Exchange Board of India SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 [Listing Regulations] and circulars issued by the Ministry of Corporate Affairs and SEBI from time to time in this regard. The Meeting commenced at 4:30 p.m. (IST) and concluded at 5:00 p.m. (IST).

B. Proceedings in brief:

- Mr. Hari Nair, Chairperson of the Board, Chaired the meeting.
- The Company Secretary & Compliance Officer informed that the Meeting was held through VC / OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India. The Company had also provided live webcast of the proceedings of Meeting.
- The requisite quorum being present, the Company Secretary & Compliance Officer called the meeting to order.
